Dear Resident/Business Owners

Haringey Council is aware of your anti-social behaviour concerns: The drug dealing in the locality; the street drinkers congregating in the area, causing nuisance through littering, urinating and noise. The Council has been working with the police, who are carrying out regular patrols of Myddleton Road to try and identify suspects, to enable appropriate enforcement action. If you see anyone engaging in anti-social behaviour or causing a nuisance please report it.

If there is an officer on duty then we undertake to call you back within 30 minutes. During exceptionally busy times the response can be delayed. You will be advised when you call if there isn't an officer on duty to respond immediately to your call, but all calls will be logged.



### **Sack Collection**

Wheelie bins will be provided for residents wherever possible. However, at some properties there is not enough room in the front garden or yard for a bin, or there are too many steps down to the pavement for our collection crews to safely move a bin full of rubbish. In these locations residents will be asked to present their refuse in sacks for the normal collection. In addition, most **properties above shops** receive a daily or weekly sack collection.



## **Bulky Items Collection Service**

Your standard weekly refuse collection service is suitable for most non-recyclable waste that you will need to put out, but some larger items will need to be collected separately. You can book special collections for bulky items through the council's contractor Veolia, which will pick up some reusable or recyclable items for free, and make a charge for other items.
